Pelaksanaan prinsip-prinsip Good Governance di Kantor Kecamatan dapat membantu meningkatkan efektivitas dan efisiensi dalam pelayanan publik, serta memperkuat keterlibatan masyarakat dalam pengambilan keputusan yang memengaruhi kehidupan mereka. Penelitian ini bertujuan untuk mendeskripsikan tentang pelaksanaan prinsip Good Governance di Kantor Kecamatan Tanjunganom Kabupaten Nganjuk. Teknik pengumpulan data meliputi observasi, wawancara, dan dokumentasi. Teknik analisis menggunakan teknik analisis interaktif dari Miles, Huberman, & Johnny Saldana. Hasil penelitian berdasarkan prinsip Good Governance menurut UNDP (Syaidinar & Ubayanto, 2021) yang meliputi akuntabilitas, transparansi, partisipasi masyarakat, dan daya tanggap menunjukkan bahwa pelaksanaan prinsip good governance di Kantor Kecamatan Tanjunganom Kabupaten Nganjuk sudah cukup baik. Namun, ada beberapa hambatan sehingga memerluka perhatian lebih seperti pemahaman masyarakat, keterbatasan akses teknologi dari masyarakat serta kurangnya minat untuk mengikuti kegiatan di kecamatan.

*The implementation of Good Governance principles in governance at the Sub-district Office can help improve effectiveness and efficiency in public services, as well as strengthen community involvement in decision making that affects their lives. This study aims to describe the implementation of Good Governance principles in governance at the Tanjunganom District Office, Nganjuk Regency. Data collection techniques include observation, interviews, and documentation. The analysis technique uses interactive analysis techniques from Miles, Huberman, & Johnny Saldana. The results of the study based on the principles of Good Governance according to UNDP (Syaidinar & Ubayanto, 2021) which include accountability, transparency, community participation, and responsiveness show that the implementation of good governance principles in governance at the Tanjunganom District Office, Nganjuk Regency is quite good. However, there are several obstacles that require more attention such as community understanding, limited access to technology from the community and lack of interest in participating in activities in the sub-district.*
